ORDER

A RATE

All prices are quoted in Euros and are deemed includes **VAT**, postage and packing. **TRESOR DES THRACES** society reserves the right to change prices in the event of increased charges, including **VAT**.

The price is payable to the order, as the payment method selected.

TRESOR DES THRACES society reserves the right to collect payment and send the package once payment is confirmed by his bank.

It will be sent an itemized bill on paper to each customer for each of its orders showing **VAT**.

DELIVERY

RETURN

The Purchaser shall, in accordance with the provisions of Article L 121-20 of the Consumer Code, a withdrawal period of 7 working days of delivery of products to return them to Seller at end of exchange or refund, provided that the goods are returned in their original packaging and in perfect condition within 7 days of delivery. Items damaged, soiled or incomplete are not included.

Return costs will be borne solely by Buyer.

The return of products must be accompanied by the invoice.

The exchange (subject to availability) or refund (of the full amounts paid, including shipping costs) will be made within 30 days after receipt by the Seller of the items returned by Buyer.
